# Playground progress – The following items discussed:

- Cameras for playground discussed Still need to address this.
- Playground rules sign Sign needs to be redone with the words swings in place of slides.

- Super Spinner to be installed week of May 1<sup>st</sup>. This will require a two-day close of the playground for curing.

## ➤ Maintenance list— The following needs to be addressed:

- o Electrical cable fix behind the wall
- o 90-degree extension for the water faucet
- Flood light replacement with theft protection
- Sprinkler system-Marie still working with the water department to detach the front marque sprinkler system from the businesses water meter on the north side. Plan is to cut the line and run a new one to merge it with the line going to the Hunter controller. Running the new line will need to be done by the landscaping company and the charge is \$500. Board agreed to the cost if the it goes as planned.
- Cracked backflow pipe- Cost to fix the pipe starts at \$250. This cost could possibly increase if other problems are found. Backflow is not needed at this time so decision made to hold off on this until next year to not deplete the budget.

## > Front landscaping and beautification

- Due to the sprinkler issues at the front marque, the purple flowers have died. Erika to pull
  these up and dispose of them. This area will be readdressed depending on the outcome of
  the sprinkler system rerouting.
- o All other beautification has been completed.

## > Commercial vehicle overnight parking sign

 Petition signed by residents and turned over to Precinct. Decision to place signs will be made on May 10<sup>th</sup> court. At that point we will be informed if the signs will be placed or not.
