Financial Report: Proposed comparison 2019 and 2020 budget handout for the financials - Marie reported the financials -

Financials:

Financial review of 2019 budget and non-budget items were reviewed on the handout to show that we are over our budget due to non-budgeted items:

• Sprinkler System - Near Flagpole valve replacement

- Electrical LED Dusk to Dawn spot light replacement
- Sprinkler System Front Marquee Hunter Node replacement and programming
- Entire front Large tree trimming and one tree removal
- Sprinkler System Across along brick wall from Flagpole valve replacement
- Sprinkler System several sprinkler head replaced or repositioned.

Financial review of 2020 budget items were reviewed on the handout to show that in order to meet this budget, there were be at \$25 increase per household on the 2020 Assessments.

- Marie took a few questions and answers from the community.
- Lee assisted in answering that were related to our governing documents or laws.

Collections:

APM has mailed the billing for the 2019 assessments.

Homeowners Forum:

- o Homeowner asked about \$30 violation letter received in which Lee responded to.
- o Homeowner asked about basketball hoops in which Lee responded to and said he would need to review our CCRs with respect to our deed restrictions.
- o Homeowner asked about if the HOA can help with a homeowner to homeowner issue they have with pit-bull dogs damaging their fence between both properties. Lee answered that the HOA does not get involved in homeowner to homeowner issues.
- o Homeowner asked about what the HOA is doing about neighbors not mowing their lawns or neighbors with broken down fences or neighbors with old abandoned cars on driveways. Lee responded to the process that APM goes thru to monthly inspection and violation letters and their process.
- Homeowner asked about progress on walking trails. Marie responded that last month (June),
 Harris County had return the design of the walking trails with a few changes that were done
 and the design was resend to Harris county for approval.
- O Homeowner asked about why WOS has no police patrol and how to get some patrols. Marie response with what the HOA Board has been researching with regards to Police Patrol. \$70,000 per year for one deputy patrol, otherwise we need to go thru the public or mud district and both have not participated in the programs. Another option is \$1800 per month which is also not feasible for the community. This is still be researched and on-going.
