Old Business:

- Landscaping Idea were requested in newsletter to all residents no responses to date.
 - Henry will work with Landscaping Company on options, including mulch, flowers, flower pots
- Front Entrance pine tree removal near brick wall that is leaning.
 - Service request with HC to extend sidewalk includes tree removals in progress.
- Sidewalk extension: Request to see if HC would extend sidewalk to the corner of the Gas Station
 - Marie to submit HC service request HCC0071069 on 12/27/2024.
 - o This would mean the removal of 3 trees along brick wall.
- Streetlight led replacement: CenterPoint contacted & we're scheduled for next few months.
- Sidewalk repairs: Harris County confirmed that WOS remains on their schedule, but they are experiencing delays due to summer storms.
- Commercial Vehicle definition & parking: Working with legal, additional night inspection delayed.
 - o Aldo to order an additional sign to install on Deed Restriction front entrance sign.
 - Board still waiting for reply from Barsalou on documentation to begin night inspections.
 - Board is looking into rules that would need 67% approval of WOS membership.
- Mailbox Security: Board will look into options, possible solar lighting

New Business

- Board was contacted about possible mechanic business disrupting road access, esthetics and harmony.
 This will be reported to APM to take appropriate action. Also, an article will be added to the next newsletter to outline this CCR restriction and to notify residents with complaints of appropriate action.
- Adopt-a-County-Mile and garage/yard sale signs. Board to clarify the program in more detail to
 understand what is permitted and not and will include an article in the next newsletter and community
 meeting on the topic for clarification.
- Next Newsletter is currently April 2025, but a FLYER will go out each Mid-June & Dec to ask neighbors to be courteous and be good neighbors during fireworks events and loud parties.
